The Maritim Hotel is perfectly integrated in the infrastructure of Dusseldorf Airport. Linked to Terminal C by a footbridge, the hotel is also very close to the A 44, A 52 and A 3 motorways, as well as the trade fair grounds. The city centre is just a few stops away on local trains. The S11 train stops at the Central Station (Hauptbahnhof).

Distance to the Central Station: 7 km  
Distance to the trade fair grounds: 4,5 km  
Distance to the historic city centre: 7 km  
InterCity Express train station: 0,5 km

Distance to Airport City: 100 m

Distance to the ESPRIT Arena: 4,5 km

You can get to the hotel by car via the A 44 motorway, taking the „Dusseldorf Flughafen“ exit. Head towards „Ankunft“ and follow the signs for „Airport City“. The Maritim-Hotel Dusseldorf is straight in front of you.

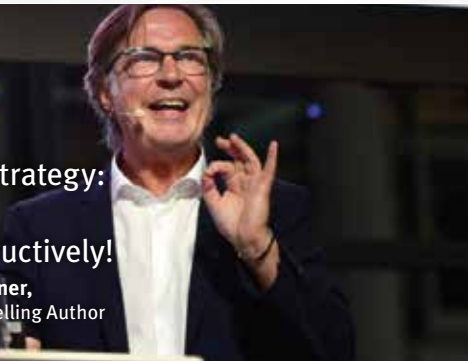
